Your personal data within the scope of this application can be gathered in electronic means via the messaging centre of our Bank, in a printed way through forms and documents or verbally during your verbal communication with our employees. Such data processing is obligatory to use the rights by data subjects stated in the Law and protect them. Other reasons that requires the Bank to process the data are preserved.

E – Where and to Whom You May Send Your Applications
